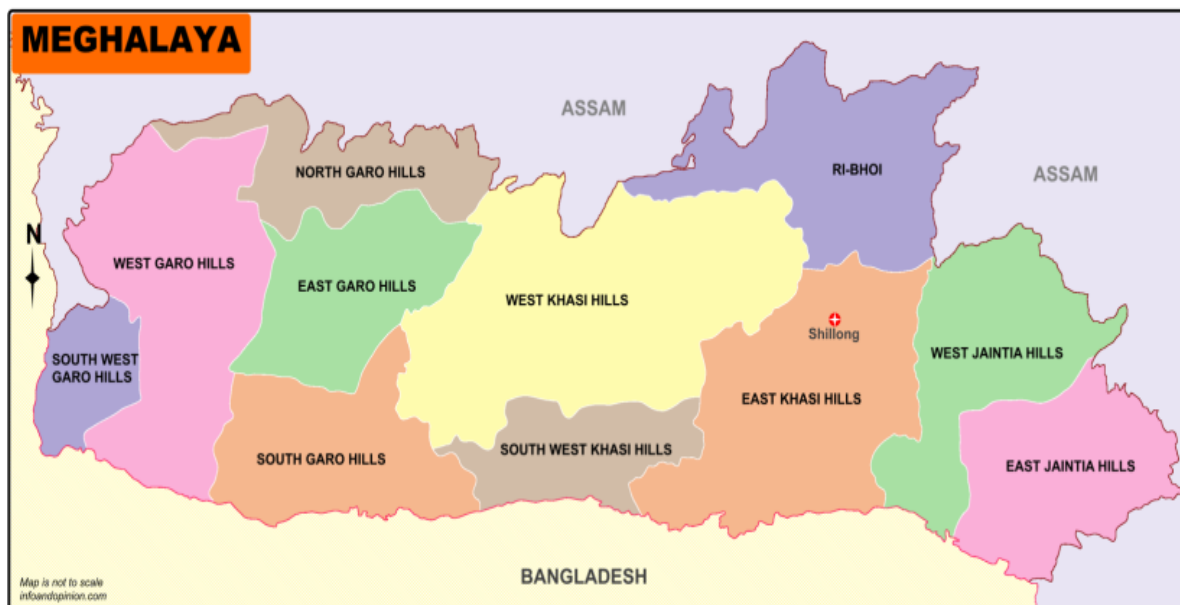

REPORT ON NISHTHA TRAINING FOR ELEMENTARY SCHOOL TEACHERS OF MEGHALAYA

1.0 INTRODUCTION

NISHTHA is a National Initiative for School Heads' and Teachers' Holistic Advancement at the elementary stage under Samagra Shiksha - a flagship programme of Ministry of Education. NISHTHA in face-to-face mode was launched on 21st August, 2019 by Hon'ble HRM Shri Ramesh Pokhriyal Nishank. Thereafter, 34 states/UTs have launched this programme in their States/UTs under Samagra Shiksha, a Centrally Sponsored Scheme. In the year 2020, the state of Meghalaya also started the training of the elementary school teachers during the month of February but out of **28,000** teachers only **3772** teachers could be trained.

The outbreak of COVID-19 pandemic has caused an unprecedented disruption to the training of the school teachers. In order to continue this learning and to reach every single teacher and pupil teachers irrespective of the board, affiliation etc., the Ministry of Education, Govt. of India has planned to organise a series of online courses on DIKSHA. The state of Meghalaya started training of elementary school teachers on the 16th October 2020

2.0 NEED & SIGNIFICANCE

- It was mandated by the Ministry of Education that all teachers including those who have been trained in the face to face mode will have to take this course on NISHTHA. Hence the state department of education issued an order to the district officials to on board all teachers for the NISHTHA online training on DIKSHA.
- Under the New Education Policy 2020, all teachers are required to complete 50 hours of continuous professional development course of their own interest. The modules developed by the NCERT for the NISHTHA training focus on holistic development of children and hence include curriculum and inclusive education health and well-being, personal social qualities, art integrated learning, initiatives in school education, subject-specific pedagogies, ICT in teaching-learning, leadership, pre-school education, pre-vocational education, etc.

3.0 OBJECTIVES

The main objectives of NISHTHA training for elementary school teachers are as follows:

- To provide continuous professional development for teachers as per the recommendation of NEP2020
- To provide awareness on latest pedagogical aspects such as Foundational Literacy and Numeracy, assessment of Learning Outcomes, Competency Based Learning, Experiential learning etc.

Each module of NISHTHA was conducted as a course in DIKSHA. So totally 18 courses were conducted. The course was to be completed within a period of three months and the following schedule was followed:

5.0. MODALITY

5.1.Orientation: On receipt of the letter from the Ministry of Education, the department of education identified a State Level Team to take the responsibility forward for implementing the programme. The first meeting between the State Level Team and DIKSHA State Point of Contact (POC) was held on the 21st September 2020 to work out the implementation plan for the state. The State Coordinator in consultation with Director, Educational Research and Training, State Project Director, Director, School Education and Literacy along with the state level team identified the academic team for translation of modules into Khasi and Garo languages, technical team for handling digital processes on DIKSHA and discussed on the modality of the course, communication system and support system.

The State Level Team also identified 160 State Resource Persons from DIETS, Teacher Training Institutes and CTEs and mapped the teachers to the ratio of 1:150 for handholding teachers in respect of academic issues. The SRPs were oriented on their roles and each SRP was to form a WhatsApp group with the teachers for necessary communication. The SRG was also connected to the state level team through social media.

For the orientation of teachers, strategic plan to reach the teachers to the last mile was done in the form of press release, radio jingles, social media, brochures and posters.



5.2. Development of courses: The identified academic team from the DERT and DIETs translated the modules into Khasi and Garo languages. Although translation was done in local languages, the official language of the state being English, it was decided that the state will run the course in English. The State Coordinator ensured that state tenants were made available in DIKSHA platform. The state contacted the DIKSHA PMU allotted to the state and made the digital infrastructure ready in DIKSHA to run courses. The technical admins created the course on DIKSHA and the content reviewers checked and approved each resource and the course for making it live

5.3. Implementation strategy : The state in order to roll out the programme, the following implementation strategy was followed:

- Identification of teachers for training: it was decided by the State Level Team that only the elementary schools teachers, who are under the category of Government and Government Aided Schools (numbering to 24006) will be trained for

NISHTHA training on DIKSHA. Under the Samagra Shiksha Abhiyan, the state has initiated Teacher Information Management System where the teachers have Unique Identification Number.

- Translation of Modules: The DERT and DIET faculty were engaged to translate all the 18 NISHTHA modules developed by NCERT
- Communication: A widespread communication strategy for teachers to take this course was planned through multi-media platforms such as newspaper, social media, radio and television. These teachers were to register through the Single Sign Up (SSU) option with their TIMS ID on DIKSHA platform. The district officials of education were also directed to communicate to teachers within their jurisdiction to mandatorily take the NISHTHA training.
- Academic Team: The State Resource Group who have earlier been trained during 2019, in face to face mode, were mapped to the teachers to the ratio of 1:160 and oriented to handhold teachers relating to academic issues.
- Support: The Technical Admins from the State Level Team were oriented by the DIKSHA PMU to upload the resource on DIKSHA platform. It was ensured that the state tenants were made available in the DIKSHA platform. The course was then made live on the DIKSHA platform
- Launch of the course: The state launched the course on the 16th October 2020.
- Teachers started the course and at the end of each course Certificate of Completion was issued.

5.4. Communication system: A hierarchical model of communication system was created by the state. Each SRGs mapped to the teachers created WhatsApp group to address the issues faced by the teachers and to improve quality of training. The SRGs and the Technical teams at the district levels were in turn connected to the State Level Team through WhatsApp group to escalate the issues and problems faced at their level.

At the end of each course a report on the following was communicated to the NISHTHA national team via email and Telegram group.

5.5. Monitoring and reporting system:

- The State of Meghalaya appointed a supervising officer to oversee the implementation of the NISHTHA training. A regular monitoring of the programme was done by the supervising officer through online meetings between the state level team and the SRGs.
- Regular monitoring of the technical team was done on a weekly basis.
- A weekly report to the NCERT NISHTHA national team was submitted every Monday.

6. Data Analyses and Enterpretation

The target for NISHTHA through DIKSHA was **24006** Head and teachers

7. ISSUES AND CHALLENGES:

- Certificate generation issues: One of the main issues was with regard to issue of certificates. Some teachers got instant access to their Certificates on course completion and some have to wait for their certificates. As per instruction from DIKSHA

instructions were floated that certificates generation takes 7 to 10 days. Many teachers faced the problem of getting certificates in a correct format like missing signatures or displaced logos.

- Compatibility issues: Since many end user used different kind of devices and apps for the training, there were some compatibility issues with some end users. The process of trouble shooting for each and every teacher facing this problem was lengthy and tedious.
- Lack of ICT skills of teachers: There is a lack of ICT skills on the takers of this course online and as such inherent inability of teachers to follow the troubleshooting steps and use of technology as a whole was experienced.
- Network issues: Poor network connectivity in Microsoft's and JIO's server end was one of the major issues for teachers not being able to complete the course as per schedule

8.0 KEY LEARNINGS:

- The NISHTHA has helped in updating of teacher data base in the state
- Teachers keen interest to take the course and update their knowledge on latest pedagogical aspects as per the NEP 2020
- The state need to have a 24/7 troubleshooting telephonic helpdesk to assist in any type of academic and technical issues

9.0. SUGGESTIONS

- Besides providing academic training to the State Resource Groups, basic knowledge on, different types of technical support should be extended such as giving step by step details of “ How ” of all processes as well, to hand hold the trainees with academic as well as other technical issues during the training.

- The data for the particular state should be made available at the DIKSHA back end to make it easier for the states to do the reporting.

10.0 CONCLUSION

In-spite of various issues and challenges faced during the training, the state was able to successfully complete the NISHTHA online training on DIKSHA for elementary school heads and teachers. Overall, the state was able to achieve at least 80% of the target.

Due to the outbreak of COVID-19 pandemic the training of the school teachers could not be carried out. However, in order to continue this training, the Ministry of Education, Govt. of India has initiated the NISHTHA courses on DIKSHA platform.




(Digital Infrastructure for Knowledge sharing) is an initiative of NCERT dedicated as a National Platform for teachers for teaching learning. This platform will be used for the online training of teachers on NISHTHA.


It is mandated by the Ministry of Education that all teachers including those who have been trained in the face to face mode earlier will have to take this course on NISHTHA.



- STEP 1** Open Play store in your smart phone
- STEP 2** Search for DIKSHA and select DIKSHA-Platform for School Education by NCTE (MHRD, Government of India).
- STEP 3** Select Install option to install the app in your smartphone. After completion of installation select Open option to open the Diksha app and choose English as your preferred language and continue.
- STEP 4** Select your role as a Teacher, and continue. Select Board Option and choose State (Meghalaya) from the list. Select Submit to continue and select English as medium and continue.
- STEP 5** Now select the desired class and submit to continue. Update your location by selecting the District and submitting it.
- STEP 6** You may close or select the "Choose a Textbook to start" option to enter dashboard and select Profile option in right bottom corner to register yourself.
- STEP 7** Select login option to continue or Register Here option to DIKSHA platform.
- STEP 8** Fill up the registration form by entering the required information, accept the terms and conditions by ticking the options and select the Register option.
