- Prior to the launch of NISHTHA 2.0, a detailed letter, highlighting the features of the NISHTHA 2.0 Courses, was emailed to all schools affiliated to CISCE in India and abroad along with the following attachments:

 - Dates and Links for Batch 1 of NISHTHA Courses
 - Frequently Asked Questions (FAQs) by teachers and the corresponding reference material in the form of tutorials.
 - Instructions for completing details on the DIKSHA platform including details to be entered in the box for ID requested by the State/Board/Organisation
- This was accompanied by an SMS to all schools informing them that an important circular regarding NISHTHA had been sent to them.
- The letter as well as the attachments were also uploaded on the CAREERS portal, which is CISCE's Online Integrated Platform for all its operations and which is used by CISCE on a regular basis for communication with its affiliated schools.
- The letter along with the attachments was also uploaded on the Notice Board of the CISCE website <u>www.cisce.org</u>.
- On 19th August, a reminder letter along with the links for the first three courses was sent to all CISCE schools together with Instructions for registration. It was emphasized that:
 - teachers must enroll in ALL THREE Courses first and then complete the Courses one by one.
 - Teachers must enroll for the above three Courses before the last date (as specified).

 In addition to the above, a DIKSHA Support Helpdesk was created to address all queries/ concerns/issues faced by teachers on a daily basis.
